You are about to purchase a product that is not simple and may be difficult to understand

#### What is this product?

The product is a combination of a policy providing sickness benefits and a tax-exempt with profits pure endowment policy payable on the member's 65th Birthday, with contributions which increase according to the member's attained age and payable to age 65. The maximum age at entry is 55. **This document shows values based upon a policy term of twenty-five years and an investor aged 40.** 

#### **Objectives**

- To provide benefits on sickness
- To build a tax-free cash sum
- To allow you to take advantage of your friendly society tax exempt savings allowance

Contributions are initially allocated to the Society's Sickness Fund and as surpluses in the Sickness Fund emerge they are distributed to members' Individual Accounts. On sickness, a benefit is payable at the full rate for the first 26 weeks, then at half rate for the next 26 weeks, then at one-quarter of the full rate for up to 52 further weeks. The insurance benefits on death included in this plan are £10 plus the value of your account payable to your family should you die. The average cost of this life cover assuming your age is 40 is £0.28 per annum.

The Summary Risk Indicator (SRI) assumes you keep the product for 25 years. You will not receive any benefits if you cease your membership before age 65. The summary risk indicator is a guide to the level of risk of this product compared to other products. We have classified this product as 3 out of 7 which is a medium-low risk class. This rates the potential loss from future investment performance as medium-low. At 65 you are entitled to receive at least the amounts credited to your Account. Any amount over this and any additional return depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you fail to make all your payments on time. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see the section "what happens if we are unable to pay you"). The indicator shown above does not consider this protection.

- This table shows the money you could get back over the next 25 years, under different scenarios, assuming that you invest £1000 per year increasing with age to £2085 at age 64 (equivalent to 982 units). However, please note that the maximum contribution you can pay is £270 per annum or £25 per month.
- The scenarios shown illustrate how your investment could perform and assume an annual distribution of surplus from the Sickness Fund of £1.15 per unit.
- The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the plan.
- The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you.
- The figures shown include all the costs of the product itself. The figures do not take into account your personal tax situation, which may affect how much you get back.

#### What are the costs?

The reduction in yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the plan itself, for three different holding periods. They include potential early exit penalties. The figures assume that you invest £1000 in the first year with premiums increasing each year to £2085 at age 64. The figures are estimates and may change in the future.

### How long should I hold it and can I take the money out early?

#### **Recommended Minimum Holding Period**

Taking into account the above information, the recommended holding period for the Plan is the full term of the Savings Plan which you agreed when you took out the Plan.

**Friendly Society** – A friendly society is a mutual organisation which has no shareholders. It is run by its members for its members. GUOOFS is a member of the Association of Financial Mutuals.
